



As of July 1, 2020, ICCB added the option to test ABE/ASE students with either CASAS GOALS or TABE 11/12. In order to administer the CASAS GOALS test and purchase testing material, you must attend CASAS Implementation Training.

CASAS Implementation Training is also required for **ESL programs** that give the paper CASAS Life and Work Reading test if they want to transition to the eTest or add the eTest as a testing option. See chart below for more information.

- determine what test levels and forms to administer
