HOW ARE STUDENTS PLACED?

- Typically placement is done based upon placement tests.
- "Student scores above or below cutoffs on relatively short, standardized math and English assessments" (Community College Research Center, 2015).
- This method misplaces many students that could be successful, either <u>under placing</u> them or <u>over placing</u> them. Some students spend time / money on unnecessary courses; some fail when they aren't prepared (Cullinan, et al., 2018).



WHY DO A CONSISTENT, MULTIPLE MEASURES APPROACH?

- Fairness: Students who can be successful should be able to avoid spending time and money in remediation.
- Motivation: Persistence is discouraged when a student is labeled as "not ready" (Cullinan, et al., 2018).
- **Positive Impact:** Emerging research suggests that the use of multiple measures can have a positive effect on student outcomes (Cullinan, et al., 2018)."
- Consistency: Consistent courses should have consistent placement requirements
- Smoother Transitions: Students have more seamless transition to the community college or the university




STATEWIDE SURVEY

- March 2018-All colleges surveyed to determine the minimum ACT and SAT scores needed to waive a placement test for:
 - Quantitative Literacy (M1901)
 - Statistics (M1902)
 - Math for Elementary Teaching (M1903)
 - General Education Math (M1904)
 - Elementary Math Modeling (M1907)
 - College Algebra
 - Writing Course Sequence (C1900 or C1900R)
 - Oral Communication (C2900)
- Colleges also reported on placement exam scores



ACT Math






ACT Math:

- College of DuPage, John A. Logan, Morton, and Oakton require placement exams regardless of ACT score for the indicated courses
- Shawnee and Southeastern use comprehensive score, rather than math sub-scores



ACT English and Reading






ACT English/Reading:

- College of DuPage, Shawnee, and Southeastern use comprehensive scores rather than English sub-scores
- Kishwaukee accepts either the comprehensive score or the English subscore



Math SAT




^{*}Danville, Lake Land, Lewis and Clark, and Shawnee report the two-digit SAT scores, rather than three-digit. The two-digit scores have been converted to three-digit scores here for comparison.

SAT Math:

- College of DuPage, Morton, and Oakton require placement exams regardless of ACT score for the indicated courses
- Danville, Lake Land, Lewis and Clark, and Shawnee report the two-digit SAT scores, rather than three-digit



SAT Reading and Writing






SAT Reading/Writing:

- Heartland, Kankakee, Lake Land, Lewis and Clark, Shawnee, and Southwestern Illinois Colleges report the two-digit SAT scores, rather than three-digit (see below)
- Only a few colleges look at SAT writing scores







PLACEMENT RECOMMENDATIONS

- Recommendations were drafted
- Chief Academic Officers and Chief Student Service Officers presented the recommendations to the Presidents Council
- Approved by the Presidents Council on June 1, 2018
- Will be endorsed by the Illinois Community College Board in October



PLACEMENT RECOMMENDATIONS

- The document <u>recommends</u> that colleges use multiple measures for placement. At this point, it is not a mandate, but a system wide agreement. Many more steps are required to reach full implementation and complete consistency.
- The recommendation suggests a list of valid measures to choose from, including the scores on those measures.
- The recommendation charges the ICCB with doing further research about the validity of those measures.



PLACEMENT RECOMMENDATIONS

- The recommendation charges the ICCB with putting together a working group to go over implementation issues. This working group must come from a cross-section of stakeholders in the Illinois community college system.
- The document demonstrates that the Illinois Community College system is aware of disparities in placement across the state and is actively working to correct those disparities in a collaborative manner.
- The ICCB has supported this effort, has been involved in high-level conversations about this work, and has worked to balance local control issues with the need for more statewide consistency on this issue.



DETAILS OF THE RECOMMENDATIONS

- Math Courses:
 - Quantitative Literacy (M1901)
 - Statistics (M1902)
 - Math for Elementary Teaching (M1903)
 - General Education Math (M1904)
 - Elementary Math Modeling (M1907)
- English Courses:
 - Writing Course Sequence (C1900 or C1900R)
 - Oral Communication (C2900)



DETAILS OF THE RECOMMENDATIONS

- PARCC score of 4 or
 5 in subject area
- ACT
 - 22 in Math
 - 19 in English
- SAT
 - 530 Math
 - 480 English
- Placement tests with appropriate scores

- High School GPA
 - English: 3.0 (on an unweighted 4.0 scale)
 - Math: 3.0 with successful completion of 4th year of math
- Transitional Math
- GED score of 165



DETAILS OF THE RECOMMENDATIONS

- May accept a lower score on individual method in combination with other placement methods or with supports (co-requisite)
- Such additional activities shall in no way infringe upon the student's ability to enroll in college-level courses
- Expiration:
 - English: no less than three years
 - Math: no less than 18 months
- Recommendation to enroll in English and math during first semester
- Other methods may award college credit and therefore placement is not necessary: AP, CLEP, IB, dual credit, etc.
