

Illinois Community College Board

SPRING 2019 LEGISLATIVE UPDATE
101st GENERAL ASSEMBLY
(Actions as of March 13, 2019)

The 2019 spring legislative session has begun and the Illinois Community College Board has been reviewing legislation, responding to legislative inquiries, and attending committee hearings, as well as meeting with legislators and interest groups. This agenda item highlights significant pieces of legislation that have implications for the Board or the community college system. A complete list of tracked bills and the status of each bill is included at the end of this summary document.

Legislation Initiated by the ICCB

[HB 3436](#) (Burke)
[SB 2119](#) (McGuire)

Community College Contracts

ICCB Position: Support

Provides that the board of trustees of a community college district may enter into a contract for goods or services procured from a competitively bid group purchase contract without adhering to the competitively bid contract requirements under the Public Community College Act. Under the current statute such purchases in excess of \$25,000 are required to be competitively bid by the college itself.

During the previous legislative session, the General Assembly enacted procurement reform (P.A. 100-43) that made numerous changes to the Illinois Procurement Code. These changes included amendments to the Governmental Joint Purchase Act (30 ILCS 525) which allowed public universities under the jurisdiction of the Illinois Procurement Code to make purchases through group purchasing organizations including from the Midwest Higher Education Compact (MHEC). Because local community colleges are not governed by the Procurement Code, the reforms to streamline purchasing through MHEC and other group purchasing organizations did not apply to the community college sector. This legislation would ensure that community colleges and public universities have the same flexibility when it comes to group purchasing.

Community College Apprenticeship Grant Program

ICCB Position: Support

This bill provides that, subject to appropriation, the Illinois Community College Board shall establish a community college apprenticeship grant program to expand opportunities for credit and non-credit education and training leading to high-demand jobs through apprenticeship programs offered in partnership with a community college and a local business or industry. Provides that the grants must be prioritized to expand apprenticeship programs to new populations, develop apprenticeships in new, non-traditional sectors, and identify ways to promote greater inclusion and diversity in apprenticeships

The grant will provide the resources to adequately meet the needs of business and industry providers that are interested in partnering with community colleges to provide apprenticeships, would allow for the recruitment of new partnerships across traditional apprenticeship fields (e.g., construction, manufacturing, etc.) and emerging fields (e.g., IT, Financial Services, Professional Services), and provide the resources to engage in curriculum development, oversight, and evaluation.

ICCB Adult Education Classes

ICCB Position: Support

As a part of WIOA implementation, ICCB has identified statutory revisions to the State's Adult Education Act to ensure compliance with WIOA. This legislation also aligns the statutory language with the current adult education program administered by the ICCB. In 2002, adult education was transferred from ISBE to ICCB but few changes were made other than switching the definition of "Board" from one agency to another. Highlights of the amended legislation:

- Provides a clearer understanding of the provisions of the law.
- Aligns with the Federal Workforce Innovation and Opportunity Act (WIOA) in which Adult Education is Title II of the WIOA.
- Aligns with statewide strategic planning activities.
- Increases instructional fees from \$3.00 to \$6.00 per unit of instruction with a maximum of \$30.00 per semester. These funds will be used for approved adult education services and activities.
- Includes a fee exemption for those students receiving public aid under the Illinois Public Aid Code.
- Proposes a generation rate for Adult Education instruction more closely aligned with the community college reimbursement rates for ABE/ASE/ESL divided by one-third.
- Provides additional definitions such as defining Adult Education.
- Removes some specific Illinois School Code language that was not appropriately placed in this legislation. This language may have been applicable before the transference of governance to the ICCB.

[SB 2121](#) (Aquino)

Business Enterprise Program – Community Colleges

ICCB Position: Support

The bill amends the Business Enterprise for Minorities, Women, and Persons with Disabilities (BEP) Act by modifying the terms "State contracts" and "public institutions of higher education" to remove references to community colleges and community college districts within the meanings of those terms. The bill provides aspirational goals for community colleges in the awarding of contracts under the Act and specifies additional information that the Business Enterprise Council is required to report for each community college district. The Business Enterprise Council shall (rather than may) collect the data needed to make its report from the ICCB.

This legislation clarifies the data reporting processes for community colleges as it relates to the reporting of goals set within the the Act for local community college districts. Because community colleges are units of local government and don't report to CMS or fall under the Illinois Procurement Code, the colleges have struggled to navigate between inconsistent processes and provide the reporting required through BEP. These changes will clarify compliance with the Act for local community college districts and ensure that the community college system is reporting on efforts to meet procurement goals.

Legislation Affecting the ICCB

HB 816 (Welch) State Agency Website Modernization

ICCB Position: Neutral

This bill requires that on or before July 1, 2020, each State agency submit to the Department of Innovation and Technology (DoIT) a plan to improve the provision of digital services, including modernizing websites and enhancing the use of data analytics. The bill further requires that on or before July 1, 2021, all State agency websites intended for use by the public shall be mobile-friendly and accessible by persons with disabilities.

HB 3088 (Lilly) State Agency Bonus Prohibition

ICCB Position: Monitor

The bill creates the State Agency and Grantee Bonus Prohibition Act. Provides that no state agency (including ICCB) may pay a bonus to its employees. Provides that no entity receiving State grant funds may pay a bonus from grant funds awarded for operational expenses to its employees. Base Operating, Equalization, Adult Education, and CTE grants all include funding for operations.

SB 1153 (Murphy) State Contract Funding

ICCB Position: Oppose

This bill provides that neither the State of Illinois nor an agency thereof shall enter into a contract, nor shall a contract be awarded, if there is not, prior to entering into such contract, an appropriation enacted for the funding of that contract. The bill is intended to prevent state agencies from entering into contracts and committing funding without a state budget in place. However, since appropriations are approved on a year-to-year basis, this language appears to prohibit agencies from entering multi-year contracts (i.e., building rent).

HB 3598 (Yingling) Comptroller Interactive Map

ICCB Position: Support

The Comptroller shall establish and maintain a Geographic Information System interactive map on the Comptroller's website that provides the boundaries of all taxing bodies in this State. The interactive map shall contain detailed information specifying the amount each taxing body levies, the function of the taxing body, and the annual budget of the taxing body. The ICCB has struggled for a number of years to obtain the GIS data to precisely define community college boundaries.

SB1376 (Rose) IBHE, ICCB, and ISAC Consolidation

ICCB Position: Oppose

This bill abolishes both ICCB and ISAC as independent boards and transfers all of the rights, powers, duties, and functions to IBHE. The legislation decreases overall membership of the IBHE from 16 to 15, with 13 gubernatorial appointments. Of the 13 appointments, at least 6 representing public universities and at least 6 representing public community colleges. There are to be 2 non-voting student members, one from a public universities and one from a community college.

The bill provides that the IBHE may require the elimination of any program of instruction, research, or public service at a public university that exhibits a trend of low performance. Provides that, in evaluating programmatic expansions and new programs at a public institution of higher education, the Board, prior to approving the expansions or programs, shall make certain findings about the region and the higher education infrastructure in this State.

Legislation Effecting the Community College System

HB 27 (Thapedi) Vocational Opportunity Act

ICCB Position: Neutral

This bill creates two vocational academies (in Cook County and St. Clair County) as residential institutions. Provides that each academy shall be a State agency, funded by State appropriations, private contributions, and endowments. The academies will offer secondary coursework to individuals who have completed the 9th grade or its equivalent—focusing on students in the 10th-12th grades.

The Executive Director of the ICCB shall sit on the Board of Trustees as an ex officio non-voting member. The sponsor has indicated that these academies will be "rebirths" of the Washburne Trade School and Jones Commercial High School, which provided instruction focused on the construction trades, information technology, and business-related services.

HB 191 (Ford) Walk-Through Metal Detectors

ICCB Position: Monitor

This bill creates the Safe Spaces in Public Places Act. Beginning with the 2020-2021 academic year, each institution of higher learning (including community colleges) must install and operate a walk-through metal detector at each public entrance of the institution and during any special event on any campus of the institution if more than 1,000 people are present at the event. The bill includes similar requirements for county courthouses, secondary schools, and hospitals.

HB 217 (Flowers) Criminal History in College Applications

ICCB Position: Neutral

This bill creates the Criminal History in College Applications Act that prohibits a public university or community college from inquiring about or considering an applicant's criminal history information at any time during the admission decision-making process. After an individual has been admitted as a student, colleges and universities may, but are not required to, make inquiries about past criminal-related activity in order to make decisions about the student's participation in campus life and to be able to provide appropriate support services. An institution may include information on its admissions materials and website that informs prospective applicants that a criminal record may affect an individual's ability to obtain certain occupational licenses or types of employment or to participate in certain clinical or other educational requirements and may provide a contact for applicants or prospective applicants to ask questions and seek advice about any restrictions. The bill also allows institutions to continue using a multi-institution application, even if the application inquires about criminal history, but requires the public college to disregard the information for the admissions process.

HB 302 (McSweeney) **Community College Vocational Scholarship**
SB 1167 (Ellman)
SB 1565 (Crowe)

ICCB Position: Neutral

This bill requires the Illinois Student Assistance Commission to establish and administer an adult vocational community college scholarship program. Beginning with the 2020-2021 academic year, the Commission shall receive and consider applications for scholarships to community colleges for people over the age of 30 who have been unemployed and are actively searching for employment and who can identify the specific training certificate, credential, or associate degree that he or she is seeking to obtain. Applicants may re-apply for the scholarship if they can demonstrate continual progress toward the desired certificate, credential, or degree. The scholarships shall not exceed \$2,000 per recipient per academic year. The scholarship program is subject to appropriation.

HB 350 (Willis) **State Universities Retirement System – 3% Rule**
SB 60 (Bertino-Tarrant)

ICCB Position: Monitor

This bill rescinds a portion of FY2018 pension reforms, reinstating the previous 6% limit (reduced to 3% in the FY2018 BIMP) on salary increases for TRS and SURS members, beyond which the employer is responsible for contributing the present value of the associated pension benefit increase. Because of the rule, many community colleges face financial penalties for promoting employees to senior leadership positions or adding additional pay for performing extra duties if the employee is within five years of retirement.

HB 901 (Guzzardi) **Higher Education College Promise Program**

ICCB Position: Neutral

This legislation requires ISAC to implement and administer a program, beginning with the 2020-2021 academic year, to award College Promise grants to Illinois students seeking an associate degree from a public community college or a bachelor's degree from a public university. A student who enrolled full-time at a public institution in the fall and applied for the grant in their initial year of enrollment would be eligible for a College Promise grant equal to the cost of tuition and mandatory fees less other scholarship and grant aid. Funding for the grant program is subject to appropriation.

HB 908 (Carroll) **Higher Education Mental Health Act**

ICCB Position: Neutral

This legislation requires IBHE to establish an advisory commission on serving and supporting students with mental health disabilities in institutions of higher education..

HB 1444 (Hoffman)

Community College Board Secretary

ICCB Position: Neutral

This bill provides that the secretary of a community college district board of trustees may be a member of that board. If the secretary is not a member of the board, he or she may receive compensation that shall be fixed by the board prior to the election of the secretary.

HB 2093 (Crespo)

Career and Technical Education Grants

ICCB Position: Oppose

This bill requires that on or before December 15, 2019, and on or before each December 15 thereafter, the Illinois Workforce Innovation Board (IWIB) must review labor market data and projections in this State and must submit to ISBE and the ICCB a list of each career area, along with a designation of one of three categories based on employment demand and average wages. The bill requires the ISBE to allocate secondary Career and Technical Education grants using a methodology that incentivizes completion of pathway sequences; enrollment in programs of study in high value career areas; and equity in enrollment in high value career area courses for low-income students.

Subject to appropriation and allocation of matching grants through the federal Perkins Act, the ICCB must administer a program, in conjunction with Northern Illinois University, to provide Community Partnership for Pathway Endorsement grants to community college districts. The ICCB is concerned that legislating where funds under the Perkins Act are to be spent reduces the flexibility of the ICCB and the local recipients to respond to needs or invest in other initiatives as appropriate.

HB 2152 (Welch)

Mental Health Early Action on Campus Act

ICCB Position: Oppose

This bill creates the Mental Health Early Action on Campus Act. The new Act provides that each public college or university must designate an expert panel to develop and implement policies and procedures to advise students, faculty, and staff on the proper procedures for identifying and addressing the needs of students exhibiting symptoms of a mental health condition; increase knowledge and understanding of student protections under the law; and provide training if appropriate. In addition, each public college or university must develop and implement a peer support program utilizing student peers to support individuals living with mental health conditions on campus and form strategic partnerships with local mental health service providers to improve overall campus mental wellness and augment on-campus capacity; specifies what the partnerships must include.

While the provisions of the bill are subject to appropriation, the ICCB and others have concerns that the appropriation level may be insufficient to accomplish the duties set forth. The ICCB has estimated that it could cost upwards of \$20.0 million dollars for the community college system to implement all of the strategies identified in the bill and reach the clinical staffing ratios.

HB 2509 (Mazzochi) Western Civilization Degree

ICCB Position: Oppose

This bill requires the IBHE, in collaboration with ICCB and ISBE, to develop a 4-year western civilization degree program that shall result in a student receiving a bachelor's degree in western civilization. The bill requires the degree to be started in high school (“year one”), continue at the community college (“second and third year”), and be completed at a public university (“final year”). The cost for the program may not exceed \$20,000 for the entire 4-year period. Any university with a post graduate degree program must accept the western civilization degree to satisfy any requirements of a bachelor's degree.

HB 2623 (Smith) Community College Affordable Housing

ICCB Position: Support

This bill amends the Public Community College Act and the Housing Authorities Act to permit community colleges and housing authorities to develop affordable housing for community college students.

HB 2803 (Welch) Higher Education Veterans Service Act

ICCB Position: Neutral

This bill amends the Higher Education Veterans Service Act to require that each public college and university annually report to the IBHE on the efforts of the public college or university in attracting, recruiting, and retaining veterans and military personnel. The bill also adds the website and social media accounts to the required advertisement for the Coordinator of Veterans and Military Personnel and Student Services at each institution. The IBHE already receives a report from these institutions on their veteran activities and costs thereof. This bill adds more items to the report.

HB 2870 (Villanueva) Higher Education Classes on Election Day

ICCB Position: Monitor

This legislation prohibits public universities and community colleges from holding any classes on the day of a general primary election or general election; however, public universities and community colleges may remain open for other purposes.

HB 3205 (Ortiz) Higher Education Financial Aid Info

ICCB Position: Monitor

This legislation provides that a university or community college may not require a student, as part of his or her financial aid verification process, to submit a letter to the university or community college indicating why the student's parent or guardian is not employed, does not file taxes, or does not have a federal Individual Taxpayer Identification Number.

HB 3570 (McCombie) Industrial New Jobs Training Act

ICCB Position: Monitor

The bill proposes a new withholding tax credit for taxpayers who enter into “an agreement with a community college in the State to establish a project.” The “credit” is equal to 1.5% of the wages paid to participating employees in the first year of participation in the program. The bill requires the Department to approve agreements. The bill does not really reduce the employer’s withholding tax liability, it merely diverts a portion of the withholding from GRF into the Industrial New Jobs Training Fund, which is to then be allocated to community colleges to cover the cost of projects. The community college is to certify to the Department the amount of the new jobs credit from withholding. To provide funds for the present payment of the costs of new jobs training programs, a community college may borrow money and issue and sell certificates payable from a sufficient portion of the future receipts of payments authorized by the agreement.

Job training services provided by the community college include, but are not limited to, the following: (1) new jobs training in manufacturing, processing, assembling, warehousing, wholesaling, or research and development; (2) adult basic education and job-related instruction; and (3) career and technical skill-assessment services and testing.

**HB 3581 (Ammons) Higher Education Early Childhood Grant
SB 2091 (Aquino)**

ICCB Position: Neutral

This bill provides that, beginning with the 2019-2020 academic year, ISAC must implement and administer a program to award Early Childhood Workforce Free College grants to all eligible child care workers seeking an associate or bachelor's degree from a public institution or a regionally accredited, online-only early childhood education degree program. To qualify for a grant, a student must be admitted to the program, apply annually, and maintain Illinois residency. The grant can cover up to the cost of tuition and mandatory fees less any other aid.

The bill also creates the Early Childhood Workforce Advisory Committee to advise the Commission on all matters relating to the Early Childhood Workforce Free College grant program and on the ways to improve and expand the early childhood workforce in this State. Provides for the membership (which includes ICCB) and support of the Committee and requires the Committee to (i) study and make recommendations to the Commission that are related to the implementation of the Early Childhood Workforce Free College grant program, (ii) conduct an analysis from data received by the Commission to ensure the program is at full utilization, (iii) address access issues to the program, including, but not limited to, geographic, financial, cultural, and workplace settings, and (iv) address ways to expand the early childhood workforce in this State.

HB 3637 (Flowers) City Colleges of Chicago Nursing Program

ICCB Position: Monitor

This bill requires that, beginning with the 2019-2020 academic year and subject to approval, each community college within City Colleges of Chicago district must offer a program in nursing.

SB 59 (Bertino-Tarrant) Dual Credit Course Fees

ICCB Position: Oppose

Per this legislation, institutions of higher education may not collect fees from a high school student enrolled in a dual credit course in excess of what the institution needs, per student, to administer a dual credit program. Any fees collected from the high school student may not be used for any purpose other than administering the dual credit program. This legislation is in response to a new fee of \$50 for dual credit through Joliet Junior College. The costs of dual credit vary widely with some community colleges offering courses for free to others charging fees or tuition.

SB 1212 (Lightford) Course Equity Act

ICCB Position: Oppose

This bill creates a Course Equity Program and Catalog which will allow “eligible funded students” to enroll in courses. The program would provide a listing of all courses (the catalog) which high school students could take. These courses will be offered through third party providers provided that the course was approved and listed in the catalog. The student could take the course with permission from the high school, or enroll for a course that was not available at the high school. All courses should align with the Illinois Learning Standards or the appropriate standard. Funding is to maximize access to courses for low-income students.

Community colleges may serve as a Course Equity Provider and offer dual credit for courses that otherwise meet the criteria for a dual credit course. Other Course Equity Program providers may enter into a partnership with a public community college to offer dual credit courses. Students enrolled in community college dual credit courses will be charged in-district tuition. As drafted, this legislation treats course offerings at the secondary level in the same manner as dual credit courses being offered by community colleges. This is not consistent with the requirements of the Dual Credit Quality Act or accreditation through the Higher Learning Commission.

SB 1255 (Hastings) Veteran Grant Program - Dependents

ICCB Position: Monitor

This bill changes residency requirements for the MIA/POW and Illinois Veteran Grant (IVG) scholarships to allow an individual to qualify who meets other requirements for the programs and, rather than requiring them to return to Illinois within six months of separating from service, requires them to have been an Illinois resident for at least 15 continuous years at the time of application.

The bill also allows IVG benefits to be passed on to a dependent under specified circumstances. While a veteran may qualify for IVG benefits after serving one year (or less, if medically discharged or serving in a foreign conflict), the ability to pass benefits to a dependent would be available only to those who have served at least six years of federal active duty, plus two years of Reserve or Individual Ready Reserve service. The veteran also may not pass IVG benefits to a dependent if he or she has federal veterans' educational benefits or has no such federal benefits dedicated only to tuition and fees that exceed the amounts available under IVG. The change allowing use by a dependent would take effect with the 2019-2020 academic year.

ICCB Position: Oppose

The bill requires IBHE to establish a uniform admission process online, which must be used at all public institutions of higher education—community colleges and universities. The admission process must have a universal application, which is to be accepted by all public institutions. IBHE must make this app available online and inform all high schools in Illinois. High school personnel must provide this information to all students and parents and allow a student to complete the application within school hours. If the applicant is not offered admission to a public university, they must be automatically referred to the community district where the applicant resides and provided with enrollment information from that district.

The process must be integrated as such that if an applicant is not accepted for admission to the public institution of higher education that they applied to, IBHE shall forward their application to other public institutions whose admission standards are reasonably in line with the applicant's qualifications and that have programs and areas of study in which the applicant wishes to enroll. IBHE must ensure that it maximizes the optimal efficiencies of each academic department of an institution and each institution itself by forwarding the application to institutions with a goal of ensuring that departments and institutions are operating with a critical mass of students to operate efficiently.

ICCB Position: Neutral

The legislation provides that, subject to appropriation, the State Board of Education must develop an Agricultural Education Pre-Service Teacher Training Program beginning at the secondary level that provides grants to (i) students who qualify as pre-service teaching students and who attend institutions of higher education that offer an agricultural education teacher preparation program, (ii) students who qualify as pre-service teaching students and who attend public community colleges that provide an articulated agricultural education teacher course of study, and (iii) non-traditional agricultural education teaching students.

ICCB Position: Oppose

The legislation amends the Dual Credit Quality Act to provide that a highly qualified high school instructor, as determined by a school board, may, with the approval of the community college, teach up to 8 hours of credit-bearing college-level courses for dual credit per academic year without having to meet any of the academic credential requirements under the Act, higher certification requirements, or additional requirements under the Educator Licensure Article of the School Code.

The bill places community colleges in a position of being in violation of requirements set by the Higher Learning Commission (HLC) for faculty qualifications. In addition, P.A. 100-1049 made significant changes to the Dual Credit Quality Act that will allow for teachers, in certain instances, to teach dual credit courses without meeting the minimum faculty requirements if the teachers are on a professional development plan.

SB 1907 (Castro)

Veterans' Education Benefits – In-State Tuition

ICCB Position: Support

Beginning with the 2019-2020 academic year, per the federal requirements for maintaining approval for veterans' education benefits, if a person who is on active military duty or is receiving veterans' education benefits, then the university or community college shall deem that person an Illinois resident for tuition purposes. The legislation is needed to fix Illinois' statutes to ensure veteran students may continue to receive the educational financial support benefits they have earned.

SB 1919 (Gillespie)

Community College Manufacturing Grants

ICCB Position: Support

This bill requires ICCB to establish and administer a manufacturing training grant program. To qualify for a grant, a community college district and a public high school located in that district must jointly establish a collaborative regional partnership with workforce development organizations, regional economic development organizations, and economic development officials in the district, along with manufacturers, healthcare service providers, and innovative technology businesses that have a presence in the district, to provide a manufacturing training program. The bill requires a grant recipient to provide the ICCB with a plan that meets certain requirements. The ICCB must establish an advisory board for the program similar to the current local program boards.

SB 1930 (Manar)

Grow Your Own STEM and Vocational Education Teachers Act

ICCB Position: Support

The Grow Your Own STEM and Vocational Education Teachers Act provides that a public institution of higher education shall, if funds are appropriated, waive any tuition, fees, and on-campus housing costs for a student who agrees to pursue a minimum of a bachelor's degree in agriculture, science, technology, engineering, or mathematics for certain teaching occupations and to teach at a hard-to-staff school. The recipient must fully reimburse the public institution of higher education for any waived tuition, fees, or costs if the student fails to teach at least 3 years at an Illinois high school located or at least 5 years at a public university or community college.

The Act also provides that a public institution of higher education shall, if funds are appropriated, waive any tuition and fees for a student who is a licensed Illinois teacher with a master's degree and who (i) agrees to pursue up to a maximum of 18 graduate hours necessary to qualify the student to teach dual credit consistent with applicable accreditation and State standards for dual credit faculty and (ii) agrees to fully reimburse the public institution of higher education for any waived tuition or fees if the student fails to teach at least 5 years at an Illinois high school after the completion of the graduate hours.

SB 1930 (Manar)

Grow Your Own STEM and Vocational Education Teachers Act

ICCB Position: Support

The Grow Your Own STEM and Vocational Education Teachers Act provides that a public institution of higher education shall, if funds are appropriated, waive any tuition, fees, and on-campus housing costs for a student who agrees to pursue a minimum of a bachelor's degree in agriculture, science, technology, engineering, or mathematics for certain teaching occupations and

to teach at a hard-to-staff school. The recipient must fully reimburse the public institution of higher education for any waived tuition, fees, or costs if the student fails to teach at least 3 years at an Illinois high school located or at least 5 years at a public university or community college.

The Act also provides that a public institution of higher education shall, if funds are appropriated, waive any tuition and fees for a student who is a licensed Illinois teacher with a master's degree and who (i) agrees to pursue up to a maximum of 18 graduate hours necessary to qualify the student to teach dual credit consistent with applicable accreditation and State standards for dual credit faculty and (ii) agrees to fully reimburse the public institution of higher education for any waived tuition or fees if the student fails to teach at least 5 years at an Illinois high school after the completion of the graduate hours.

SB 1937 (Manar) Coordinator of Veterans & Military Personnel Student Services

ICCB Position: Support

The bill requires a public university or community college to use its “best efforts” to hire a veteran of the armed services as the Coordinator of Veterans and Military Personnel Student Services. Coordinator must create and maintain a contact list of all veterans attending the public college or university and may communicate with veterans of the public college or university via email or other electronic means. The community colleges all have a named Veterans Coordinator but not all colleges hit the 1,000 onsite, daily, full-time student headcount threshold as required by current law (Higher Education Veterans Service Act) for employment of a Coordinator.

SB 2046 (Brady) Early College High School Program

ICCB Position: Neutral

The bill requires that each school district that maintains a secondary school must offer an early college high school program for its secondary school students to be completed by the student within 2 school years. The early college high school program consists of a series of dual credit courses that allows a high school student to earn, within 2 school years, both a high school diploma and an associate degree or up to 2 years of academic credit toward a bachelor's degree from an institution of higher education. A student enrolled in an early college high school program is exempt from the payment of any registration, tuition, or laboratory fees charged by an institution of higher education and the school district is responsible for all costs associated with the program.

SJR 22 (Schimpf) IAI Course Transfer Efficiency Study

ICCB Position: Neutral

The resolution directs the IBHE and ICCB to jointly identify any shortcomings in attaining the goals of Public Act 99-636 that the General Education Core Curriculum courses transfer between institutions with full credit towards a baccalaureate degree.
