As part of this responsibility, the technical staff will install the LIFT Text Transcoder product to produce a reader-compatible text only version of the college web site.	Technical staff that support web applications have also received recent, state training in the use of technology to support users with disabilities. The technical staff will monitor current and emerging technology that will enhance the website. The technical staff will work closely with the Web Accessibility Committee, which will advise and approve actions for web development. Web Coordinator completed an on-line course through University of Illinois at Urbana-Champaign in late 2005. This course led by Dr. Jon Gunderson, the Director of IT Accessibility Services for the University. Web Coordinator also participated in an online Webcast workshop from Harper College. Workshops on web design currently are offered as individual sessions (Intro to DreamWeaver, et al) and as components of multi-session seminars (Bytes of Technology). Oakton will work toward a greater emphasis on accessibility issues.
